NO MEMBERSHIP FEES!

All sign-ups require a 50% deposit. Upon sign-up, you will automatically be enrolled in a <u>MONTHLY PAYMENT PLAN WITH A VALID CREDIT CARD ON FILE</u>. Balances will be divided over 3 months for each 17 week semester. The charges will be made on the 1st of each month. The payment must be collected within 7 days from the 1st of each month or a 1.5% late fee will be charged for overdue payments.

No refunds will be given in the middle of the Season, only make-ups.*

The maximum number of make-up lessons per semester is 2.

You must give a 24 hour notice for a cancelled lesson, no shows will not be given a make-up.

* ALL MAKE-UPS MUST BE COMPLETED BY THE LAST DAY OF EACH SEMESTER.

By signing below, I fully understand that I must remit a 50% deposit upon enrollment and will automatically be enrolled in a monthly payment plan. Balances will be divided over 3 months for the 17 week program. All balances will be charged on the 1st day of each month. I accept that enrollment in RWTT programs is for the full session and that no refunds will be given for withdrawals or absences after the session begins. Under no circumstances will the deposit be refunded. Credit to be applied at management's discretion.
